SUPERINTENDENT'S REPORT

Dian Burns had discussed with Superintendent Raymer a \$500 scholarship opportunity for three to four high school students to work 3-4 hours per week on Fridays and during the summer. At the last inservice, the school safety procedures were reviewed and the teachers toured the buildings. Mr. Raymer's main concern is communication so he met with Sheriff Beeson and Ryan Murray, Cheyenne County Emergency Management, and discussed 'code red'. This is not an option right now but Sheriff Beeson will do further checking to see if there is something available for a notification system. Mr. Raymer and Randy Miller have reviewed what is allowable by the State Fire Marshall on the door locks. Anne Coon, Sheriff Beeson and Superintendent Raymer will be attending an active shooter response training, ALICE, in Colby on April 26-27.

Superintendent Raymer reported that Lacey Grogan wants to offer a safety program for kids one week in the summer. He received information about a workshop in Winfield titled 'Uncommon Athlete, Coaches & Captains Leadership Training' that he plans to send the athletic director, a couple of the coaches and a student/athlete leadership team to on April 26.

Mr. Raymer advised the board of some upcoming dates he will be gone.

A one-three year strategic plan will be developed for the district. Superintendent Raymer will start this process by sending out a form to all board members and ask for their input on district goals.

APPROVE SENIOR TRIP ITINERARY - Carried 6-0

It was moved and seconded to approve the itinerary for the senior trip to Santa Fe, New Mexico, on April 13 to April 15, 2018.

APPROVE AGREEMENT - Carried 6-0

It was moved and seconded to approve a three-year contract with Eagle Communications, Inc. to provide internet services.

APRROVE BID - Carried 6-0

It was moved and seconded to accept the bid in the amount of \$18,494.45 from S&T Communications for a telephone system.

The Summer Projects list was reviewed and Superintendent Raymer, Randy, and the building committee, Kasey Sabatka, Jared Sowers and Nick Ketzner, will do a walk through and prioritize the projects.

The capital outlay priorities were reviewed and the BOE was updated on the progress of the projects.

APPROVE JH/HS TRACK RULES – Carried 6-0

It was moved and seconded to approve the training rules for Junior High and High School Track for the 2018 season.

High School graduation will be held on Saturday, May 12, 2018, 11:00 a.m. In addition to the current board members, Dale Hazuka, will hand out diplomas. The 8th graders will be recognized at the junior high awards assembly, Tuesday, May 15, 2018, and Nick Ketzner will hand out certificates.

Superintendent Raymer was asked to remain.

It was moved and seconded to approve Kalin Ritchey as Junior High Assistant Track Coach for the 2018 season.

Copies of the Superintendent Evaluation Instrument which was developed in July under the direction of Mike Lucas, McPherson & Jacobson, was distributed to the board members. Mr. Raymer's evaluation will be conducted at the April meeting.
