<u>SUPERINTENDENT'S REPORT</u>

Superintendent Homburg reported that the new activity bus had arrived and made it's first trip. Several students qualified for the state music festival in Hesston in April. The elementary roof is being repaired and state assessments have begun.

DISCUSSION/ACTION ITEMS

Chris Walden, JH/HS Athletic Director, reported that the St. Francis superintendent advised that at this time, they were not interested in combining junior high volleyball. Discussion was held on how to proceed and Mr. Walden was directed by the board to contact Rawlins County and Brewster/Triplains to see if they were interested in cooperating with Cheylin for this sport. Mr. Homburg will follow up with the St. Francis superintendent regarding junior high sports.

APPROVE FULLTIME KINDERGARTEN - Carried 7-0

It was moved and seconded to hold kindergarten 4 days per week beginning with the 2017-2018 school year.

Projected preschool enrollment and expenses for the next two years was discussed. A grant to fund the program for the 2017-2018 year will be submitted in June.

Cindy Wiley, certified driver's education instructor, will teach drivers education classes again this summer. Cindy is the driver's education instructor for St. Francis and Atwood. Cindy will be paid \$1000 by the district and also receive the state reimbursement. In addition, each student will pay \$75 for the course. Classes for Cheylin students will begin on July 3rd and run through July 20th. Students are eligible at age 14, and we anticipate 16 will participate. Classes will be held M-F from 8 to 10 a.m. and students will have driving/vehicle time at a minimum of 30 minutes per day.

A committee was established to review the student handbook. The committee members are Anne Coon, Amy Hendricks, Kelly Leach, Anita Pochop, Mr. Raymer and Mr. Homburg. A draft will be presented at the June board meeting.

APPROVE CONSULTANT - Carried 7-0

It was moved and seconded to hire Mike Ronen, Southwest Plains Regional Service Center Consultant, to conduct a Superintendent/Board goal setting session in July or August.

APPROVE GRANT - Carried 7-0

It was moved and seconded to apply for a grant from Bird City Century II in the amount of \$2,500 for the purchase of cafeteria tables for the McDonald concessions area.

It was the consensus of the board to pursue a grant from the Dane Hansen Foundation to replace the lights in the McDonald gym.

The capital outlay priorities were reviewed and the BOE was updated on the progress of the projects.
