SUPERINTENDENT'S REPORT

Mrs. Angelos advised that since next year junior high sports will be starting during the school day and continuing after school, we will not be able to continue to use the flip schedule. The current schedule is great for the junior high/high school students as they don't miss as many core classes. However, the elementary teachers prefer to have all their core classes in the morning.

The teacher vacancies, industrial arts, music/band/choir, 7-12 language arts, are posted on the KEEB website. Mrs. Angelos would like to keep the drivers education embedded in the curriculum but that will not be a possibility for next year. She is working on some options for next year's freshman class to take classes this summer.

Superintendent Angelos has been working with the emergency management and sheriff's departments on a mock drill for an active shooter situation. Prior to the drill, there will be training for both students and teachers. In addition, parents will be notified by letter of the training exercise. State assessments are coming along well and there have been minimal problems with the internet.
