ADOPT AGENDA - Carried 7-0

It was moved and seconded to adopt the agenda as presented.

OPEN FORUM/COMMUNITY INPUT

There were approximately 80 patrons in attendance for the open forum regarding the proposal of a sports cooperative agreement between Cheylin and St. Francis schools. A list of patrons that addressed the board is available upon written request at the district office.

EXECUTIVE SESSION - Carried 7-0

KESA Update

Amy Hendricks presented on behalf of the district leadership team to give an update on the KESA process. As we are nearing the end of the cycle, Amy stated that we have made progress on the two goals that were set at the beginning of the cycle, those being Professional Learning Communities for teachers and Individual Plans of Studies for students. The KESA team and Superintendent Edmundson have met with the Outside Validation Team. We will find out our accreditation status in a few months.

ACCEPT DONATION - Carried 6-0

It was moved and seconded to accept a gift offer from Roland H. Hoffman Revocable Trust in the amount of \$75,346.60 to be used for scholarships.

ACCEPT GRANT - Carried 6-0

It was moved and seconded to accept the grant from the Patterson Family Foundation in the amount of \$6,500 to be used for the purchase of AEDs, first aid kits, and signage.

COMPUTER REPLACEMENT - Carried 6-0

It was moved and seconded to approve the quote from Reach Solutions in the amount of \$18,018.00 for the replacement of student and staff laptops.

The projected enrollment for preschool next year is approximately 10 students. Discussion was held regarding charging a fee for out of district students. No decision was made.

Dan Carson, certified driver's education instructor, will teach driver's education classes this summer. More information will be available at a later date.

Mrs. Edmundson, Mr. Bouza, and teacher representatives will be reviewing the student handbook. Any revisions or changes will be brought to the board for final approval.

Capital outlay priorities for the summer include: installing auto-flushing toilets and faucets, installing a dishwasher, replacing the football field light poles, and giving a facelift to the McDonald gym locker room.

TUITION REIMBURSEMENT PLAN - Carried 6-0

It was moved and seconded to approve the Cheylin Tuition Reimbursement Plan for the 2022-2023 school year.

Mrs. Edmundson is working on the class schedule for the 2022-2023 school year. It will be approved at a later date.

Summer school will be held two days a week during June and July. More information will be available at a later date.
